We interviewed Policy Practitioners from 7 national organizations

Theme:

"... Of course, research informs our policy development..."

Framing in Ross Brownson, et al's Evidence Framework:

Type 1 evidence- Why is this a problem....e.g., tobacco causes disease and death; access to insurance improves cancer outcomes; etc....



BUT- for the purposes of this work, and seeking how to facilitate collaboration between IS researchers and policy practitioners, we are really seeking information on how they collaborate with researchers on what we would see as Type 2 and 3 evidence- that is, how do these practitioners use- what works as evidence informed approaches on their strategy (Type 2)

and how do they apply this in the field (Type 3)....
